You can only grant this role to groups that have the Jira Software User role or the Jira Software Admin role2.

As an organization admin, you can delete both managed and unmanaged accounts. Managed accounts are those that belong to your organization and are verified by a domain or an allowlist. Unmanaged accounts are those that do not belong to your organization and are not verified by a domain or an allowlist. Deleting an account removes the user's access to all Atlassian products and services, and deletes their personal data.

Other tasks, such as configuring an email processor in Jira Software, adding a custom email address, customizing a notification scheme for a Jira Software project, and managing personal notification settings, are typically done by a Jira admin or user with the appropriate permissions and do not necessarily require organization admin privileges.

As a result, there is only one task (verifying the email domain) that can only be performed by an organization administrator.

Answer: C Explanation:

This number usually represents the total number of users listed in the Manage Accounts section. Since the number of "deactivated" accounts is 0, this means that all 8 accounts are active. This doesn't directly tell us if these users are from a verified domain, if they have 8 verified email addresses, or if they are all billable (as some may be users of a free product). So, the most definite conclusion is that there are 8 entries on the Manage Accounts page.
